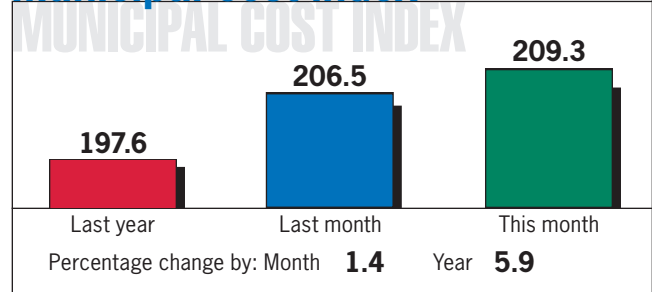

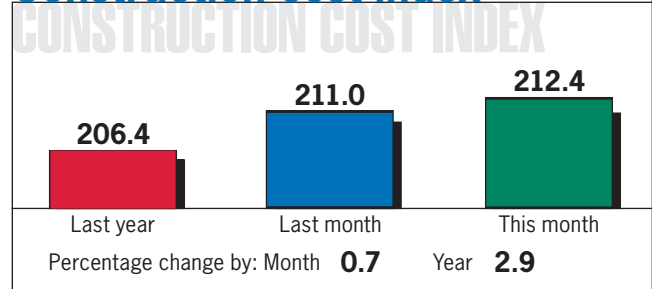

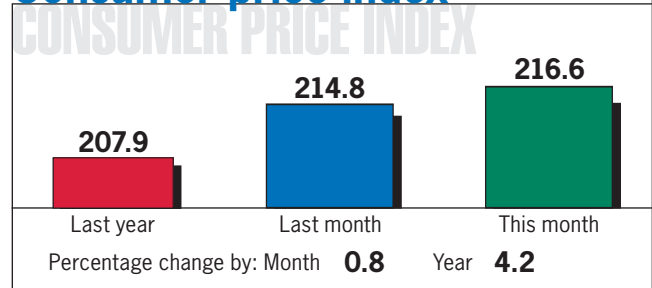
Municipal cost index



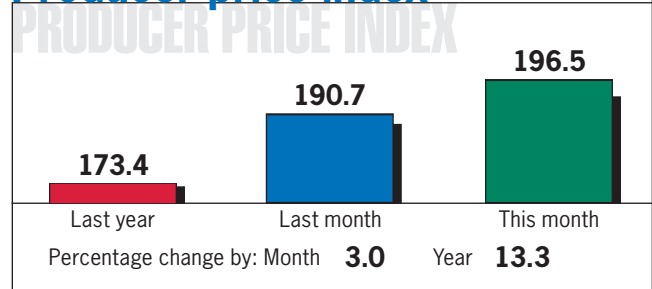
Construction cost index

The CPI and PPI figures published in this issue are from May 2008. The construction cost index is from June 2008. The municipal cost index incorporates those three indexes.
